




## Update from Executive Director JEFFREY A. MATTY, JR.





## Pennsylvania Equine Coalition News

On Tuesday, February 6, Governor Josh Shapiro delivered his annual budget address to a joint session of the Pennsylvania House of Representatives and Senate. As is typical, Governor Shapiro used the opportunity to highlight his public policy priorities and initiatives. That same day, Governor Shapiro presented the fine details of his proposed executive budget, which lays out his recommended spending priorities for each state government department and agency.

The Governor's budget proposal serves as a starting point for the House and Senate, which then typically introduce their own modified versions of the budget that reflect their respective funding and policy priorities.

Overall, the Governor's proposed budget was good news for Pennsylvania's horseracing and breeding industry. Prior Governors have previously proposed funding new, large-scale policy initiatives by transferring significant money from – or in some cases eviscerating – the Race Horse Development Trust Fund (RHDTF), which supports the industry's purse structure and breeder incentives. Fortunately, Governor Shapiro did not recommend any major new transfers of money from our industry. The Governor did, however, recommend the continued transfer of money from the RHDTF to support the Pennsylvania Fairs, the Pennsylvania Veterinary Lab, and the Animal Health and Diagnostic Commission for a total transfer of \$14.659 million. These are line-items that have come out of the trust fund for the past decade, although as part of last year's budget the PTHA and the other horsemen/breeder groups that make up the Pennsylvania Equine Coalition successfully worked with our supporters in the legislature to eliminate the transfer of \$5.35 million for the Animal Health and Diagnostics Commission. Further reducing these transfers, which impact our purses, will be one of our industry's top priorities during this year's budget process.

The PTHA and the Pennsylvania Equine Coalition also are closely monitoring legislation that would regulate and tax so-called "Games of Skill." These are unregulated machines, which perform almost exactly like slot machines, that you may have seen at corner convenience stores, clubs, or bars. There is little doubt that these games of skill are cutting into slot machine revenues at brick and mortar casinos like Parx.

This is a concern because the Race Horse Development Trust Fund is funded entirely by an assessment on slot machine revenue. As a result, the cannibalization of slot machine revenue due to games of skill has had a direct impact on the funds available for purses and breeder incentives. This cannibalization – from both games of skill and other forms of expanded gaming, such as online slots and sports wagering – has resulted in a 17.2 percent decrease in money paid into the trust fund over the past five years. Our goal is not only to reverse that decline, but ensure that the RHDTF returns to full funding so that we once again have robust purse structures to support our horsemen.

The PTHA and the Pennsylvania Equine Coalition's goal for this year is to allocate a portion of the revenue from the Games of Skill or other forms of gaming to help offset the cannibalization of the RHDTF that has occurred. In the coming weeks and months, the leadership of the PTHA will be meeting with legislators to educate them about the importance of the racing industry to the state's agricultural economy, explain how the cannibalization has adversely impacted horsemen, and make the case for increased funding.

#### What is the Race Horse Development Trust Fund?

The Race Horse Development Trust Fund (RHDTF) serves as a source of funding for purses, breeder incentives, and beauth (populate populate for the Depression and breed)

health/pension benefits for the Pennsylvania racing and breeding industry. It was created by Act 71 of 2004 (The Pennsylvania Race

Horse Development and Gaming Act), legislation that legalized slot machine gaming in the Commonwealth with a primary intent to enhance live horse racing in the state.

The legislature created the RHDTF because it wanted to ensure that rural, agricultural areas of Pennsylvania benefitted from legalized gaming. Legislators also realized that gaming expansion would adversely impact the handle, or wagering on horseracing, which traditionally funded racing purses and breeder incentives.

The fund is supported through a casino assessment that is calculated based on the slot machine gross terminal revenue at the state's six Category 1 casinos. Following efforts by past Governors and some in the legislature to use the RHDTF to fund other government programs, the PTHA and other horsemen and breeder groups were successful in adding legislative language that restricts the ability to utilize the fund for non-racing related budget items. Specifically, Act 42 of 2017 states that the assessments "are not funds of the Commonwealth" and that "the Commonwealth shall not be rightfully entitled to any money" from the trust fund. The language, however, did permit the transfer for certain "historical" line-items transfers that had previously been approved by the legislature.

#### The State Budget Process in Pennsylvania

The Commonwealth of Pennsylvania has a complex system to pass an annual state budget, with the so called "budget season" officially kicking off in early February of each year with the Governor's Budget Address to the legislature. During his budget address, the Governor typically highlights his policy priorities and goals. The same day as his budget address, the Governor submits his proposed budget to the legislature.

The Governor's budget proposal, as its name implies, is just that:

a recommendation/request from the Governor to the legislature. Shortly after the budget address, the Pennsylvania House of Representative and Senate typically hold several weeks of budget hearings. Usually, each hearing focuses on a specific state agency or department during which the leadership of the respective agency outlines their budget priorities and fields questions from legislators.

Following these budget hearings, the House and Senate each develop a budget bill that reflects the priorities of their respective chamber. This typically involves numerous changes to the Governor's proposal. The budget bill then goes through the normal legislative process, providing both the House and Senate with the opportunity to amend and approve the bill. This usually involves negotiations between the Republican and Democratic leadership of both the House and Senate, as well as the Governor's Office to reach a compromise budget bill that reflects the priorities of each chamber and the Governor. Those budget negotiations and sometimes be contentious, particularly when the majority in the House and Senate, as well as the Governor.

The legislature's goal is to adopt a new and final budget by the start of each fiscal year, which commences on July 1. Once the budget bill is approved by a majority of members of both the House and Senate, it is then sent to the Governor for his approval.

Young people's involvement in this industry is essential to the sport's survival and for evolving with innovative ideas. Here at PARX Racing, trainers' children are frequently seen carrying on their parents' legacy.

Born in Langhorne, PA Ben Dunn was raised by parents who are horse enthusiasts. Ben was motivated to continue his studies after graduating from Neshaminy High School by his mother Felissa Dunn, a trainer here at PARX, and his father John Dunn, a recently retired PARX trainer. Ben's original professional choice was to train people, not horses. After that, his mother began letting him choose the horses for their stable. Thirsty Pappy, a chestnut gelding, is his current favorite horse in the barn. He watches racing replays and particularly enjoys Thirsty Pappy's latest victory. Ben beamed as he remembered the triumph, saying, "Nothing better than watching him with his ears up – just eight lengths clear."

As for Ben's future intentions, he mentioned that he respects and loves athletes and that he can't compete anymore owing to hip injuries from playing tennis. He quipped that training a horse is very different from training a person, "Humans can tell you that they eat this much, that they eat perfectly but really can be going out to the candy store and loading up on junk but horses, you give them their feed and hopefully they eat it."

When Ben believes he is ready, he wants to go on his own obtain his trainer's license and go as far as he can, "Everyone says that the Derby is the goal and I have the rest of my life to get there. When you got the rest of your life you shoot for the stars, hopefully, you hit the moon."


## OUR CONDOLENCES...
